Rohlif, City Manager, which will amend the City Manager's compensation as stated in Addendum No. 3 of said Agreement. All other terms and conditions of the Agreement dated April 11, 2017, shall remain in full force and effect except to the extent they may be modified by this Addendum. ADDENDUM NO. 3

THIS ADDENDUM NO. 3, dated the 23rd day of June, 2020, to that certain AGREEMENT dated the 11th of April, 2017, by and between the **CITY OF NEWPORT NEWS, VIRGINIA**, a municipal corporation of the Commonwealth of Virginia, and **CYNTHIA D. ROHLF**, City Manager.

WITNESSETH:

For and in consideration of the following terms, conditions, mutual covenants and other good and valuable considerations, the receipt of which is acknowledged between the parties hereto, it is mutually agreed as follows:

The AGREEMENT dated April 11, 2017, by and between the **CITY OF NEWPORT NEWS, VIRGINIA** and **CYNTHIA D. ROHLF**, is hereby amended, effective July 1, 2020, by changing the paragraphs listed below of the aforesaid AGREEMENT, to provide as follows:

4. The City shall pay to the Manager the amount of Two Hundred Fifty-One Thousand Nine Hundred Eighty-Six and 00/100 Dollars (\$251,986.00) per annum, as salary. In addition to this salary, the City shall pay on behalf of the Manager deferred income in the amount of Twenty-Six Thousand Dollars (\$26,000.00) per annum, which shall be paid into a portable retirement plan(s) designated by the Manager.

6. (a) The City shall provide the Manager Six Hundred Twenty-Five and 00/100 Dollars (\$625.00) per month in lieu of a motor vehicle, and the Manager will be responsible for the cost of all fuel and repairs and for insurance on the vehicle up to a liability limit

prescribed by law. The City shall provide additional liability insurance coverage through the application of the City's automobile self-insurance fund as identified in Article XXXVI of Chapter 2 of the City Code.

(b) The Manager shall be a member of the Virginia Retirement System in the same manner and receive all other benefits and entitlements as provided by the City to all other regular, full-time employees and officers of the City.

(c) Coverage under the City's self-insurance fund for job related incidents shall be provided by the City to the Manager.

All other terms and conditions of the Agreement dated April 11, 2017, shall remain in full force and effect except to the extent they may be modified by the provisions hereof.
